

TENTATIVE WORK PROGRAM CYCLE



REGULAR CYCLE

1 JULY – OCTOBER:

Interact with elected officials. Balances TWP to allocations received.

DECEMBER:

Conduct Public Hearing and present to sub-committees.

DECEMBER:

Present to Monroe County Board of County Commissioners and Miami-Dade County Transportation Planning Organization (TPO) Governing Board.

JANUARY/FEBRUARY:

Compile District plans to create the Statewide Tentative Work Program. Submit Statewide preliminary Draft Tentative Work Program to Governor's Office, Legislature, Florida Transportation Commission and Department of Economic Opportunity.

MARCH:

Florida Transportation Commission (FTC) conducts a statewide public hearing to receive public input for the Tentative Work Program. The Legislature also convenes in March.

JULY:

After the appropriations are approved by the Legislature, the Work Program is adopted by the FDOT State Secretary.

SR 5/US 1 LONG KEY BRIDGE OVER LONG KEY CHANNEL BRIDGE REHABILITATION PROJECT 455886-1

Status

Design begins in 2027

- Rehabilitation of the superstructure and substructure for the bridge
- Extend the bridge service life
- Enhance safety
- Maintain mobility, evacuation and emergency response needs






SR 5/SEVEN MILE BRIDGE REHABILITATION PROJECT 446231-1 & 455887-1

Rehabilitation Project Status:

Design is underway

- Preserve the bridge until replaced
- Repair bridge elements below the bridge and columns





SR 5/SNAKE CREEK BRIDGE REPLACEMENT PROJECT 442670-2

Status:

- Feasibility Study completed in 2019
- PD&E Study begins in 2026

- Evaluate rehabilitation and replacement of the bascule bridge with a fixed bridge
- Consider adding protected sidewalks and bicycle lanes
- Analyze possible changes to the current weigh station


Design begins 2026

Project Details:

- Adding new asphalt
- Adding a boardwalk trail
- Installing retaining walls

The Florida Department of Environmental Protection (DEP) was awarded a \$10 million SunTrail grant to construct this project.







Status:

Design is underway

- Repaving and restriping the intersection
- Reconstructing an area of the intersection
- Installing a pump station to mitigate flooding at the intersection





SR 5/US 1 /OVERSEAS HIGHWAY MM 87.2 TO MM 90.1 ROADWAY IMPROVEMENT PROJECT 447810-1

Status:

Design is underway

- Repaving and restriping the road
- Upgrading guardrail and roadside barriers
- Installing sidewalk, curb and gutter to replace the barrier wall north of Woods Avenue
- Upgrading detectable warnings at trail crossing locations
- Upgrading pedestrian signals at Woods Avenue

Status:

Design is underway

- Improving roadway and drainage
- Changing the roadway elevation
- Adding two new pump stations and upgrades to the existing drainage
- Widening the northbound lanes towards the golf course to accommodate a bi-direction bicycle facility and sidewalk
- Improving pedestrian signalization and pavement markings
- Adding new lighting



FLAGLER CORRIDOR SR 968/FLAGLER ST FROM SR 821/HEFT TO SR 5 BUS EXPRESS RAPID TRANSIT PROJECT 437782-1

Status:

• Feasibility study phase is initiated (FM 437782-3)


Project Details:

January 2024 - the TPO unanimously requested to place the PD&E study in abeyance and to initiate a study to evaluate an elevated fixed guideway system along Flagler Street from Downtown to FIU









SR 968/FLAGLER STREET & SW 1 ST SW 27 AVE TO SW 6 AVE BUSINESS ACCESS TRANSIT (BAT) DEMONSTRATION PROJECT 450733-1


Status:

 Additional traffic analysis and Final Design is underway.

- Re-purposing outside lanes into Business Access and Transit Lanes (BAT)
- Applying pavement markings
- Evaluating data for future rapid transit concepts







NORTH CORRIDOR

SR 9/SR 817/NW 27 AVE FROM NW 215 ST TO NW 62 ST HEAVY RAIL PREMIUM TRANSIT PROJECT 438076-1

Status:

- FDOT is the lead agency for the project
- In May 2023 FDOT and DTPW collaborated to conduct a Value Engineering Workshop
- PD&E restarted in 2024
- Design is partially funded

- Implementing a premium transit service
- Elevated heavy rail system is the preferred transit technology

SMART PROGRAM COMMUTER RAIL PROJECT

Status:


 Department contribution is \$200M in FYs 25 through 30

- Providing commuter rail service along the existing Florida East Coast Railway
- Enhance regional mobility and reduce congestion
- Provide other transportation service options
- Reduce the number of vehicle trips resulting in a positive impact on the roadway network

Status:

US 1 to NW 62 Street

PD&E Study is in 2029

NW 62 Street to NW 143 Street

PD&E Study began June 2024

Study Details:

- Review and analyze potential impacts for the proposed transportation improvement
- Preserving the operational integrity and regional functionality of I-95, and the regional transportation network throughout Miami-Dade, Broward, and Palm Beach Counties
- Enhancing emergency evacuation and response times.
- Offer more mobility options for motorists and transit users
- Provide additional capacity along the corridor





LUDLAM TRAIL

SR 976/BIRD RD, SR 90/SW 8 ST, SR 968/FLAGLER ST NEW BRIDGES PROJECT 450835-3

Status:

- In partnership with Miami-Dade
 Parks and Recreation and Open Spaces
- Design is underway


Project Details:

Constructing three pedestrian bridges along the proposed trail at the following locations:

- The intersection at SW 40th Street/Bird Road
- The Intersection at SW 8th Street/Tamiami Trail
- The Intersection at Flagler Street







SR 860/MIAMI GARDENS DRIVE EAST OF SR 93/I-75 TO NW 79TH PLACE RECONSTRUCTION PROJECT 438864-2

Status:

Design is underway

- Widening the road to add one travel lane in each direction
- Adding a shared-use path
- Modifying medians
- Upgrading storm water drainage, lighting, signs, and pavement markings
- Adding new signals at major intersections







- Providing long term mobility options






