Professional Summary / Background

Thirty (30) years of construction law and construction litigation experience, principally as a Senior Partner with Moye, O'Brien, Pickert, Dillon & Masterson, LLP (MOPDM). Though based in Maitland, Florida, MOPDM is a construction litigation boutique that has been recognized for its sophisticated nationwide and international practice. The firm's core client base has included several ENR Top 100 contractors, institutional owners, and multiple ENR Top 20 engineering firms.

Practice has concentrated on resolving large and complex construction disputes, throughout the U.S. and internationally, primarily in the infrastructure, light rail, major bridge, airport, high speed rail, vertical (private and public), commercial and industrial sectors. Has extensive experience with mega-projects and alternative delivery systems, especially for design-build, design-build-finance and Public-Private Partnership delivery methods. A principal focus of his practice has involved serving as counsel on major and mega-projects where claim values ranged from \$100 million USD to over \$1 billion in dispute. These engagements have typically included early involvement – project counsel services – for the development, or investigation for defense, of massive claims, impacts, delays and disruptions, often followed by ADR (dispute review board, neutral evaluation, mediation) as well as binding arbitration and litigation (state court, federal court and administrative tribunals). Nonbinding ADR processes – particularly dispute review board and neutral evaluation – have been extensively used and highly successful in helping the parties receive meaningful feedback and resolve all issues.

Practice has spanned a broad range of representing construction industry participants with different viewpoints, including design-builders, owners, developers, design/engineering firms, contractors, subcontractors and sureties. Practice has extended to all phases of legal services – from procurement (contract review, preparation and negotiation, and bid protests) to project counsel services for the development/investigation of claims to the prosecution/defense of disputes in all forms of dispute resolution, including appeals. Experience is unique in its breadth to understand the dynamics and decision-making processes necessary to achieve successful dispute resolution both in the public and private sectors, whether the disputes are small or rise to the level of “bet the company” matters.
