Directed 5 separate consultant CEI contracts and 12 construction Projects valued at over 119 million dollars. This work was conducted primarily on I-75 from SR 44 north to the Alachua Marion county line, 45.5 miles of milling, resurfacing, and construction of additional lanes, widening the corridor to 6 full travel lanes, major bridge widening, structure construction and modifications. 17.3 miles of bridge widening and roadway reconstruction in Sumter county from Hernando county line to SR 44, total I-75 corridor length of 62.8 miles. Supervised over 50 consultant CEI personnel, including 5 resident engineers, 5 project engineers along with numerous inspection and support personnel. Conducted reviews and evaluations of the personnel and coordinated FDOT, CEI and the contractors personnel to resolve and foreseen issues that naturally arise at major construction. During the I-75 work from SR 44 & US 441 to downtown Inverness, I was awarded the State of Florida Urban Project Award by the Florida Transportation Builders Association. I directly managed over 20 FDOT personnel, including project engineers, administrative assistants, inspectors, senior inspectors and other essential personnel. Directed the Ocala office staff and coordinated their efforts with the representatives of the FHWA, various environmental agencies both state and federal to facilitate timely completions and insure quality products. Was instrumental in forming the freeway management team in Ocala, Marion county for the I-75 construction corridor which I served as chairperson for 3 years. Involved in original construction of US 301/441 (the sling shot route) from Ocala north to Alachua county line also Hwy 301 north of Citra to Alachua county line. Western most part of SR 44 including 7.5 miles of 2 lane roadway, a boat ramp, parking lot, 2 lane bridge over the Salt River, 2 borrow pits, several concrete box culverts, a rolling surcharge to displace a 3-4 foot layer of muck and an embankment. Four laneing of SR 40 from Ocala through Silver Springs, an extremely environmental sensitive area. While with FDOT, I was responsible to the construction office resident engineer for safe and timely construction of a multitude of projects ranging from minor maintenance contracts to multi-million dollar roadway and bridge projects. I was senior project inspector on the first major asphalt hot mix recycling project done in Florida in 1979, 7 miles of divided 4 lane US 4411 in north Marion
