In 1988, I began my career with Caltrans Office of Structure Construction (OSC) and obtained my P.E. (Civil) in 1994, and more recently a certified Qualified SWPPP Practitioner (QSP). After 12 years with OSC, I joined Lim and Nasceimento Engineering, LAN, as Senior Bridge Engineer and Project Manager. When LAN was purchased by AECOM, I was promoted to Associate Vice President and Operations Manager for the CM Division covering the California, Washington St., and Oregon territories. I moved to Harris & Associates, Inc. in 2010 as a Sr. Project Manager, and in Sept. 2015 I accepted a position with Vali Cooper and Associates, inc. as the Florida Regional Manager.

During my 27 year career, I have been directly responsible for the construction of 80 Bridges, including 27 Bridge widenings, miles of roadway, Tens of thousands of square feet of retaining and sound walls, MSE walls, Landscape projects, waterlines, hazardous materials management, sewer projects, dewatering, Bridges over navigable waters, and work regulated by most state and federal permitting agencies, including the US Navy.
