Areas of Professional Competence

Personal Management and Supervision at any level. Fiscal Management of Budgeting, estimating, and Cost Accounting. Extensive knowledge of building codes, zoning restrictions and legal criteria to construction management. Also, knowledge of labor relations, contract negotiation procedures, safety regulations (OSHA Title 29 Use), fire prevention codes (NFPA) and pertinent electrical codes.

Summary of Experience

- In my duties as company owner, supervisor, and laborer, I have obtained, with a lot of help from others, a complete well-versed knowledge of all forms of construction management from multi-family housing and road construction to high-rise buildings. I also have a complete working knowledge of all site work and utilities, including mechanical construction of hospitals.
- While employed with Rush Engineers, at one time as General Superintendent in charge of ten different job locations with each over one million dollars, each returned good profits for the owners and developers.
- While self-employed, I specialized in site work and underground utilities, doing highrise buildings where the whole contract had to be obtained to get utilities.
- While employed with Cone Brothers, I was assistant to the Vice-President, Richard Fagan, in charge of miscellaneous contracts, dealing in paving and grading curbs for Cone Brothers Contracting Company.

- While I was Area Manager in charge of the north Area of the state of Florida for Wright and Lopez, Inc., we dealt only in telecommunications for Southern Bell Telephone. In my district, at the time, we employed 157 people divided into 33 crews, 6 district managers and 3 offices. We grossed over \$450,000.00 per month and were returning a very good profit.
- □ While I was Project Manager at Coastal Plains, Inc., I was in charge of three projects; one in west Texas for Sprint, one in Sumter, South Carolina for MCI, and one in Washington, D.C. All three returned above-average profits; all three grossed over ten million dollars.
- While I was Project Manager for Escoe Green, Inc., the company grossed over fourteen million dollars in the first year alone. Prior to my joining Escoe Green, they were grossing only about six million dollars per year. Being one of only two Project Managers, I feel that I was a major part of the growth of this corporation.
- As Project Manager for D.A.B. Constructors, Inc., of Brandon, Florida, a road building company including earth wall bridges and all major utilities, worked only for the Department of Transportation.
- The Hillsborough County project was a 4.5 million dollars project. We made a large profit on this project.
- □ No. 13130-34371, State project in Manatee County, this 9.5 million dollar project has also shown a very good profit.
- Project No. 13130-34401 in Manatee County, a 2.5 million dollar project completed April 30, 1980.
- Project No. 151015150-3571, a 7.75 million dollar project in Tarpon Springs, went well and showed a profit.
- □ A small bridge at Frog Creek in Manatee County, a 1.75 million dollar project.
- At present, I am Chief Engineering Inspector for the City of Lakeland. My duties require Inspection of all site work and development in this City to include clearing, grading, curbs and gutters, sub-base, paving, storm water runoff, sanitary sewers, water pipe installation, etc.
