Profile

My career specializing in primarily municipal heavy highway construction began in 1965 with what eventually became known as the Florida Department of Transportation in Pinellas County, Florida. I started as a rodman on a survey crew and worked up to party chief. The department at that time offered what was called the Highway Engineer Training Program to those qualified through competitive selection and I was fortunate enough to be chosen. After completion of the program my placement was at Bartow Maintenance as coordinator for the organization of crews and equipment for this facility and working at the district

and state level to help standardize resources and put production standards in place for maintenance yards statewide. I worked with the department for eight years and credit the experience gained during that time with what successes I achieved throughout the remainder of my career.

I went on to work in the highway construction industry gaining experience in asphalt plant management along with the associated responsibilities of overseeing the production, testing, material acquisitions, bidding and contract administration. My career has also included extensive work in the heavy highway construction side of the business with the associated duties inclusive of:

- General management of the company
- Estimating and pricing heavy highway projects upward to \$30,000,000
- Managing and overseeing the construction of heavy municipal highway projects upward to \$20,000,000
- Administering schedules for those same projects
- Overseeing job cost for those same projects
- Overseeing constructability reviews for those same projects prior to bid and on a continuing basis throughout the project to overcome those problems typically encountered through the course of most jobs
- My strengths on the field side include a strong knowledge of earthwork, underground installations, grading operations, clearing and grubbing as well as installation of surface features.

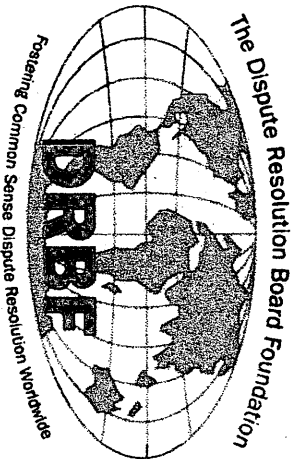
