# CTQP Issues

Asphalt Failure rates

- Encourage students to study before they go to class. Educate up front.
- Are allowed to challenge test questions.
- Show them where to get the manual, or tutor if they have one failure.
- Need to comply with the ADA requirements of hearing impairment, visual impairment.
- Can give oral examinations upon request.
- Go over some of this information with the providers
- TRT is also looking over the exam and course.

## **OSHA Safety Awareness Training (Stanley Youmas)**

Input from Districts as to what each District is doing

- D1 Felt that registration was not easy. Had to do the survey every time they had to do another session – did not want to take the time. Slow to load – took 15 – 20 minutes and by that time most of them were gone. Registration page confusing. If registration page could be modified that would help.
- D2 Some had problems registering. Did not get credit for taking class.
- D3 Not participating
- D4 A lot of their people are already trained. Had some problems getting into the system. In the future will most likely use instructor led.
- D5 Bought Clarity system. It covers most of the training. Several people in the district not in favor of the course.
- D6 A couple of people started the course, but had so much trouble registering, etc. did not finish. Agrees with D1 if that page could be modified it would be better.
- D7 16 people had taken and passed. Registration is cumbersome.
  Problems with the trenching course. DCE will send Dave Sadler a memo.
  Will be addressed at the next meeting.
- Turnpike not allowed to participate
- SMO Ken has taken, but no one else. SMO is not written into the requirement. Recommends taking to Safety Department to let them look it over.
- Yvonne will send out correct Tress numbers for this training.
