SECOND EMERGENCY ORDER
(Pursuant to Executive Order Nos. 20-277 and 20-278)**

I hereby find that the Department of Transportation's timely performance of disaster response functions related to Hurricane Eta is hindered by the application of procedures imposed by statute, rule, or order.

Therefore, pursuant to the authority granted by Executive Order Nos. 20-277 and 20-278, I hereby extend my First Emergency Order to apply to the following counties: Alachua, Citrus, Dixie, Gilchrist, Hernando, Hillsborough, Levy, Manatee, Marion, Pasco, Pinellas, Sarasota, and Sumter.

This order shall expire on the earlier of the expiration or rescission of Executive Order 20-277 or November 27, 2020, unless extended by me.
