Recommendation:

At this time, the FE TRT, by majority vote, does not recommend approval of Ozmatic, Inc. as an FE 2 Provider. Concerns are listed below.

The area between tables does not look sufficient to maneuver easily, which presents obstacles to exiting the room for personal or emergency situations. There is no apparent space or table for the instructor and equipment.

The television does not appear to be in a location easily viewable to all participants, which may hinder learning. A picture of a projector unit is included in the Provider's request. If the projector is to be used, the FE TRT cannot decipher where content will be displayed from the photos provided.

Consider removing some tables and chairs to provide more free space and reduce class size (6 participants) or consider a larger location.

(5) Review of Final Estimates Level 2 course updates

A. Course Material:

Updates are scheduled during the 2025/2026 Fiscal Year.

Scott Sikorski has recommendations for revisions to the Final Estimates 1 Course material and will send them to the TRT Chair.

Sue Wilson stated the scores she has seen lately for the FE2 course are good.

One TRT member expressed concerns with the instructor who presented the material in her class a few months ago. The TRT Chair requested surveys from the CTQP Program Administrator who responded that they only have two sessions for the FE instructor, and they date back to 2021.
