Re: Florida Gas Transmission Company Encroachment Agreement State Road Highway 694 Pinellas County, Florida FPID Number 256931-2-52-01

Florida Gas Transmission Company, LLC ("Florida Gas") has completed its conceptual review of the preliminary plans for the above-referenced project (the "Project"). Based on this review, Florida Gas has determined that relocation of the Florida Gas pipeline facilities located within the Project limits (the "Pipeline Facilities") could be necessary pursuant to the attached Conceptual Encroachment Agreement (**Attachment "1**"). This letter is to memorialize the mutual understanding of Florida Gas and the FDOT as to the manner in which the potential relocation of the Pipeline Facilities and construction of the Project could occur.

As Florida Gas receives additional information from the FDOT regarding the Project specifics, Florida Gas will prepare and submit to the FDOT the most cost-effective, operationally feasible and prudent route alternative for relocation of the Pipeline Facilities, along with initial cost estimates.

Between now and then, it is Florida Gas's understanding that the FDOT will not undertake any Project-related work that will materially interfere with the operation of the Pipeline Facilities without first obtaining the consent of Florida Gas. To that end, Florida Gas would ask that the FDOT immediately contact Kevin Duke, Florida Gas's Operations Manager for the area (ph: 813-466-3326; e-mail: <u>kevin.duke@energytransfer.com</u>), to discuss and coordinate any Project-related work that might occur in Florida Gas's easement.

If the Pipeline Facilities have to be relocated, it will be necessary for the parties to modify the Conceptual Encroachment Agreement to account for the quantity and quality of easement interests that will be assigned to the FDOT or relinquished. A survey of the relocated Pipeline Facilities will be instrumental to making the necessary modifications, and Florida Gas will share such information with the FDOT prior to submitting modifications to the Conceptual Encroachment Agreement.

If the FDOT is in agreement with this letter and the attached Conceptual Encroachment Agreement, please countersign this letter and the Conceptual Encroachment Agreement. Florida Gas will then sign and provide you with executed copies.
