RESOLUTION NO. 98-1

A RESOLUTION OF THE CITY OF VENICE, FLORIDA, AUTHORIZING EXECUTION OF UTILITY RELOCATION MASTER AGREEMENTS FOR THE ADJUSTMENT, CHANGE OR RELOCATION OF CERTAIN UTILITIES WITHIN THE RIGHT OF WAY LIMITS OF STATE ROAD 45 (U.S. 41, BUSINESS) AND STATE ROAD 45A (U.S. 41, BYPASS), AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the State of Florida Department of Transportation proposes to engage in certain projects for constructing, reconstructing or otherwise changing a portion of State Road 45 (U.S. 41, Business) and State Road 45A (U.S. 41, ByPass), which shall call for the location, protection, and/or relocation and adjustment of the City of Venice utilities on said projects; and

WHEREAS, the plans for the said construction, reconstruction or other changes are to be reviewed by the State of Florida Department of Transportation and the City of Venice; and

WHEREAS, the State of Florida Department of Transportation has presented the City of Venice with Utility Relocation Master Agreements to circumvent the current necessity of processing a separate agreement for each individual state highway project involving City of Venice utilities.
