RESOLUTION NO. 31-96 OF THE CITY OF LAKE WORTH, FLORIDA, AUTHORIZING EXECUTION OF UTILITIES RELOCATION MASTER AGREEMENTS FOR THE ADJUSTMENT, CHANGE OR RELOCATION OF CERTAIN UTILITIES WITHIN THE RIGHT-OF-WAY LIMITS OF THE STATE HIGHWAY SYSTEM, EFFECTIVE DATE.

WHEREAS, the Department proposes to engage in certain projects for constructing, reconstructing or otherwise changing a portion of the State Highway System, which shall call for the location, protection, and/or relocation and adjustment of the City of Lake Worth utilities on said Projects; and

WHEREAS, the plans for the said construction, reconstruction or other changes are to be reviewed by the State of Florida Department of Transportation and the City of Lake Worth; and

WHEREAS, the State of Florida Department of Transportation has presented the City of Lake Worth with Utilities Relocation Master Agreements to circumvent the current necessity of processing a separate agreement for each individual state highway project involving City of Lake Worth utilities.
