A RESOLUTION AUTHORIZING EXECUTION OF AN UTILITIES RELOCATION MASTER AGREEMENT FOR THE ADJUSTMENT, CHANGE OR RELOCATION OF CERTAIN UTILITIES WHERE LOCATED ON PROPERTY IN WHICH THE CITY HAS NO COMPENSABLE INTEREST; AND PROVIDING WHEN THIS RESOLUTION SHALL TAKE EFFECT.

WHEREAS, the State of Florida Department of Transporation proposes to engage in certain projects for construction, reconstruction or other change of portions of the State Highway System; and

WHEREAS, in order for the State of Florida Department of Transportation to complete said projects, it may be necessary that certain utilities and facilities located on property in which the City holds no compensable interest be adjusted, changed or relocated; and

WHEREAS, the State of Florida Department of Transportation having requested the City of Clearwater, Florida, to execute and deliver to the State of Florida Department of Transportation an Utilities Relocation Master Agreement, agreeing to make or cause to be made such adjustments, changes or relocation of such utilities and facilities as set forth in the plans and specifications for that project, and said request having been duly considered;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CLEARWATER, FLORIDA, IN SESSION DULY AND REGULARLY ASSEMBLED, AS FOLLOWS:

- 1. That the Mayor, City Clerk, City Manager and City Attorney
 be and they are hereby authorized and directed to make, execute and deliver to
 the State of Florida Department of Transportation an Utilities Relocation Master
 Agreement for the adjustment, change or other relocation of utilities and
 facilities located on property in which the City holds no compensable interest.
- 2. That a certified copy of this Resolution shall be forwarded to the State of Florida Department of Transportation at Tallahassee, Florida.
