WHEREAS, the State of Florida Department of Transportation having requested the City of Tarpon Springs, Florida, to execute and deliver to the State of Florida Department of Transportation a Utilities Relocation Master Agreement, agreeing to make or cause to be made such adjustments, changes or relocation of said utilities and facilities as set forth in the plans and specifications for that project, and said request having been duly considered,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF THE CITY OF TARPON SPRINGS, FLORIDA, that the Mayor and the
City Manager be and they are hereby authorized and directed to make,
execute and deliver to the State of Florida Department of
Transportation a Utilities Relocation Master Agreement for the
adjustment, change or other relocation of utilities and facilities
located on property in which the City holds compensable interest,
and for which the City is entitled to be reimbursed for the cost of
said utility relocation,
