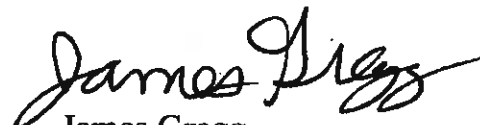

The purpose of my letter is to request an amendment to Florida's FY07 CVISN Grant. The request is for a budget reallocation as described below. This reallocation is necessary to better reflect updated costs for these projects. This request represents a 7% percent budget reallocation (\$219,342.67 / \$3,136,226.00).

- Increase the grant request amount for the Department of Agriculture LPR System Expansion from \$24,000 to \$93,342.67; this is an increase of \$69,342.67.
- Increase the grant request amount for the Automated Permitting System Upgrades to \$300,000; this is an increase of \$150,000.
- The funds for the above adjustments should be deducted from the Virtual Weigh Station project; total grant request amount to be transferred from this project is \$219,342.67.

Attached to this letter is a table to track the FY07 Grant request amounts. The table shows the original grant request amounts, the reallocated grant request amounts after the amendment signed on 2/17/10, and the budget request amounts that reflect the reallocation requested above.
