Price proposals will be stored, unopened, until the date and time of Public Opening of the Price Proposal and Public Announcement of Prices.

Bid Bonds, using the Department issued forms, will be received in the same manner described as above for the Proposal if submitting the proposal electronically. Proposal Guaranty's secured as certified checks, cashier's checks, etc., will need to be submitted via USPS, FedEx, UPS, etc., and be received by the Department by the date and time identified in the advertisement.

References in the RFP to the Technical and Price Proposal format instructions pertaining to number of copies, as well as submittal location instructions for receiving Technical and Price Proposals, are hereby revised to include electronic submittal via email, as described in this addendum, as another acceptable method for the proposal submittal. All other format and location instructions remain unchanged.
