Contract Descr: Winter Weather Event

The purpose of this Contract is to provide Winter Weather Event (WWE) Support pursuant to forecast temperatures below freezing with expected ice formation on bridges during winter months in the event that Department contractors, under contracts E2V97 and E2X03, fail, refuse, or are otherwise unable to perform WWE Support as required by the Department pursuant to these contracts. As such, contractors obligated to provide WWE Support under contract E2V97 or E2X03 are not eligible to submit a bid for this Contract. The Contractor shall provide all labor, mobile equipment (i.e., pickup trucks), fuel, and incidentals to complete the work described in this Contract. Activities include, but are not limited to, pre-event planning, coordination, and field operations (day and/or night) during potentially hazardous inclement weather.

This Contract includes all state roadways in Duval County within District Two but mainly focuses on Interstate bridges (including J. Turner Butler Boulevard), bridges to barrier islands, and the major commuter bridges in Jacksonville (i.e., the St. Elmo W. Acosta Bridge, the Isaiah David Hart Bridge, the John T. Alsop Jr. Bridge (aka the Main Street Bridge), the Mathews Bridges).

The Contractor shall provide a letter to the Department at the time of bid, from a surety authorized to do business in the State of Florida verifying the Contractor is bondable in the State of Florida. For the purposes of this Contract the dollar amount is established at \$150,000.00.

Awarded Contractor must execute documents within five (5) calendar days, excluding Saturdays, Sundays, and state holidays, with General Liability and Worker's Comp insurance.

The Department, at its sole discretion, may award one or more contracts. If more than one award is made, award will be based off lowest responsive bid then the next lowest responsive bid and so forth and activated in the same order based on the Contractors availability and ability to satisfy the needs of the Department at the time contacted. No quantities are quaranteed and there will be no unit cost adjustment for quantities required over or under the estimated quantities.
