The Specifications Package shall be amended as follows:

Page 26, Special Provisions

Subarticle **572-6.2 Litter** – **General:** is deleted and replaced with the following:

572-6.2 Litter - General: Remove and dispose of litter within the Department's right-of-way. Meet the desired level of quality for Roadside Litter as detailed in the Maintenance Rating Program Handbook. Removal of litter and graffiti from roadway and roadside areas is performed for aesthetic and safety reasons. Perform all necessary litter and graffiti removal detailed herein. The scope of litter removal activities to be performed under this contract along State Road 8 (I-10) shall be in accordance with 572-6.3.

Page 31, Special Provisions

The Aesthetics Performance Criteria Table contained in Subarticle **572-6.5 Aesthetics Performance Criteria:** is deleted and replaced with the following new table:

AESTHETICS PERFORMANCE CRITERIA TABLE	
Non-Performance Identification	Deductions
Failure to meet characteristic performance score requirements	Deduct, an amount equal to 0.25% of one-third of the annual contract amount for each MRP point below 80 on any characteristic performance score (deductions for litter removal will not be assessed for litter along I-10 that is the responsibility of RESPECT of Florida. The presence of litter along I-10 will be evaluated by the Department within 24 hours of mowing operations.

Failure to provide a minimum	\$2,000 per occurrence
of 2 weeks advance written	
notice to the Department's	
Project Manager for each	
mowing cycle.
