The Improvements under this Site-Specific Contract consist of reworking and restoring non-paved shoulders, slopes, roadside ditches, the removal of stumps and hydro seeding slopes located in the right-of-way of SR 8 (I-10), east of the Apalachicola River Bridge (MP 1.044) to east of the SR 267 interchange (MP 21.383) in Gadsden County. Other services required to achieve this work include maintenance of traffic, and furnishing borrow material. The contractor shall provide offsite disposal of all debris generated during this work, in accordance with Federal, State and Local regulations. Mobilization and Maintenance of Traffic will be incidental to the other pay items listed.

This contract has a budgetary ceiling of 2,000,000.00.

The quantities shown on the Bid Price Proposal are approximate and only represent estimated planned requirements based on historical or specific project needs. The Department does not guarantee any maximum or minimum quantity, any range of quantities, or the exact quantities shown for each bid item. The Departments estimated quantities and the Contractors bid price will be used to calculate a total bid amount.
