The Improvements under this Work Document-driven Contract consist of maintaining crape myrtle trees, located in the right-of-way of SR 10 (US 90), in Leon and Jefferson Counties, between Apex Drive (MP 8.267) and the Jefferson County Line (MP 19.323), in an effort to improve the overall appearance and health of each tree. The contractor shall provide off-site disposal of all debris generated during this work, in accordance with Federal, State & Local regulations. Maintenance of Traffic, Mobilization, and cost associated with providing on-site supervision by a certified arborist or other approved landscape professional shall be incidental to existing pay items in the contract.

Contractor Experience Form number 850-070-09 (Experience in Landscaping) is required to be submitted with this bid.
