The Improvements under this Lump Sum Contract consist of constructing a new Break Room Addition area at both the Eastbound and Westbound Rest Area facilities along Interstate 10 (State Road 8) in Leon County. As part of the construction of these new additions, work shall also include maintaining pedestrian and parking space access, demolition and removal of designated portions of existing buildings/sidewalk, relocation of landscaping, relocation of utilities, foundation construction, electrical wiring, and installation of new HVAC mechanical equipment. Complete details of the required work are provided in the accompanying signed and sealed plans. Coordinate all work with the Department Asset Maintenance Contractor for the rest areas so as to not disrupt existing Department operations at the facilities. Mobilization and Maintenance of Traffic are incidental to the Lump Sum pay item.

A Builder License or General Contractor License is required for this project. For buildings three (3) stories or less in height, a Builder's License or General Contractor License is acceptable. Buildings more than 3 stories in height require a General Contractor License. This building is less than 3 stories in height.
