The work specified under this Work Document-Driven Contract consists of a bi-weekly cleanup and disposal of roadway debris from the paved surfaces of State Road 8 (Interstate 10) and a portion of State Road 281 (Avalon Blvd) in Santa Rosa County. Locations of through lanes, ramps and paved shoulder surfaces are shown in Appendices. Cleanup cycles will be scheduled to commence on Monday of every other week. Weather permitting, each cleanup cycle must be completed with-in 4 consecutive calendar days. All litter and debris removal included, but is not limited to, trash, tire debris, vehicle parts, tarps, lost cargo, metal, junk, and any other debris that are unsightly or could pose a safety hazard or cause damage to vehicles. Mobilization and Maintenance of Traffic are incidental to the pay items listed.
