The work under this Lump Sum, Site-specific Contract in Gadsden and Leon Counties consists of removal and replacement of existing reflective pavement markers (RPMs), installation of new RPMs (median openings, islands, and traffic separators), refurbishment or replacement of thermoplastic pavement markings, and painting of curbs and traffic separators with reflective paint. Painting curb island nose markings will require surface preparation such as sweeping, cleaning, and weed removal for full coverage and adhesion. Details of work at each location are outlined in the Appendices. This is a Lump Sum Contract with only one pay item listed in the Contract.
