The improvements in this Work Document-Driven Contract consists of miscellaneous concrete repair to be performed on a call out basis in Jackson and Washington Counties. The work will consist primarily of the removal and replacement of damaged sidewalk, curb and gutter, ditch pavement, driveways, inlet tops, curb ramps and mitered end slabs. Work may include miscellaneous asphalt repair and seeding and sodding around completed areas. Maintenance of Traffic and Mobilization will be incidental to the pay items provided. This contract has a budgetary estimate of \$350,000.00.

The quantities shown on the Bid Price Proposal are approximate and only represent estimated planned requirements based on historical or specific project needs. The Department does not guarantee any maximum or minimum quantity, any range of quantities, or the exact quantities shown for each bid item. The Department estimated quantities and the Contractors bid price will be used to calculate a total bid amount. This total bid amount will then be used to determine the low bidder, however, actual payment under the awarded contract will be based on actual quantities completed.
