Contract Descr: PONCE DE LEON MAINTENANCE - SR 83 AND SR 20 BANK AND SHORE

Improvements under this Work Document-Driven Contract consist of the placement of Bank and Shore Rubble as well as Ditch Lining Rubble along SR 83 (US 331) and SR 20 in Walton County. This rubble will be used to fill, re-contour and restore eroded slope and ditch bottoms, which begin at a point approximately 25 feet from edge of pavement or approximately 10 feet behind the existing guardrail extending to the toe of slope or bay infringement. All work is to be performed within the roadside area between the State road and landward of the mean high-water line. No equipment or materials are permitted at any time waterward of the mean high-water line. Periodic lane closures will be required. Lane closures may be performed between 8:00 am and 3:00 pm with prior approval of the Engineer. Removal and replacement of guardrail may be necessary to accomplish dumping and spreading of rubble. All guardrail to be replaced at end of each work day. Mobilization, Maintenance of Traffic and removal & replacement of guardrail shall be incidental to the pay items listed.
