Contract Descr: MIDWAY MAINTENANCE - SHOULDER DITCH RESTORATION

The Improvements under this Push-button Contract consist of reworking and restoring non-paved shoulders, slopes and roadside ditches along State Roads in Gadsden and Leon Counties as directed in the Work Documents. Other services required to achieve this work include providing for Maintenance of Traffic (MOT), furnishing borrow material, maintaining pedestrian and driveway access, grassing and watering disturbed areas. Contract services will be requested on a call-out basis; four call-outs are anticipated for this Contract. For bidding purposes, the quantity of disturbed earth for each call-out should be anticipated to exceed 5 acres. A separate pay item is not provided for permit fees. The overall budgetary ceiling on this contract shall not exceed \$350,000.00. Mobilization is incidental to the other pay items listed.

This contract has a budgetary ceiling of ***\$350,000.00***

The quantities shown on the Bid Price Proposal are approximate and only represent estimated planned requirements based on historical or specific project needs. The Department does not guarantee any maximum or minimum quantity, any range of quantities, or the exact quantities shown for each bid item. The Departments estimated quantities and the Contractors bid price will be used to calculate a total bid amount. This total bid amount will then be used to determine the low bidder; however, actual payment under the awarded contract will be based on actual quantities completed.
