ARTICLE 4-1 is deleted and the following substituted:

4-1 Intent and Scope.

Details of work at each location are outlined in the Appendices. This is a Lump Sum Contract with only one pay item listed in the Contract. All references to payment under individual pay item numbers, regardless of where those references are contained in the Contract Documents or when in time any such pay item reference is incorporated in the Contract Documents, are superseded by the pay item references in this Special Provision.

Pay adjustments as shown in the Contract Documents, regardless of where those pay adjustments are referenced, shall not apply, except as provided for in 9-2 Scope of Payments.

SUBARTICLE 4-3.1 is deleted and the following substituted:

4-3.1 General: The Engineer reserves the right to make, at any time prior to or during the progress of the work, alterations or changes, whether a significant change or not, and such alterations in the details of construction, whether a substantial change or not, including but not limited to alterations in the grade or alignment of the road or structure or both, as may be found necessary or desirable by the Engineer. Such alterations or changes shall not constitute a breach of Contract, shall

APPENDIX A: SITE LOCATIONS AND DETAILS

LOCATION 1: SR 10 (MAHAN DR./US 90 EAST) & SR 59 SOUTH GAMBLE ST. (55020000 & 55150000)

From just east of driveway for Lighthouse Thrift store, MP 8.581 (55020-000) to MP 19.323 (includes section within Jefferson Co. from MP 15.635 to 16.265) & SR 59 S/Gamble St. from Jefferson Co. to US 90 MP 0.000 to 0.111 (55150-000)

- Remove and replace all thermoplastic traffic and pedestrian markings (e.g., lines, arrows, messages, symbols, chevrons, crosswalks, stop bars) of SR 10, SR 59, and intersecting side roads.
- Remove and replace all double yellow thermoplastic traffic markings on all side streets in accordance with Standard Plans; Index 711-001; Sheet 7; Note 3.
- Remove and replace all reflective pavement markers (RPMs) within the right-of-way in accordance with Standard Plans; Index 706-001; Sheets 1 and 2.
- Remove and replace blue RPMs in accordance with Standard Plans; Index 706-001; Sheet 6.

SPECIFIC EXCEPTIONS OR EXCLUSIONS FOR THIS SITE LOCATION:

- Double yellow centerlines of Chaires Cross Rd. (EB shoulder) are excluded. (Note Double yellow centerlines of Crump Rd. (NB shoulder) are <u>not</u> excluded)
- Double yellow centerlines of Archangel Way are excluded.
