Rights of entry with the appropriate property owner(s) shall be obtained by the Department prior to any work being done outside of the right of way. Coordination with electrical utility owners is required when near transmission facilities. Mobilization is incidental to other pay items listed.

This Contract has a budgetary estimate of \$100,000.00.

The quantities shown on the Bid Price Proposal are approximate and only represent estimated planned requirements based on historical or specific project needs. This total bid amount will then be used to determine the low bidder, however, actual payment under the awarded contract will be based on actual quantities completed. Work Documents will identify the location, description, amount of work to be accomplished, and the number of calendar days to complete the work.

A Proposal Guaranty will not be required on indefinite quantity contracts, such as work document driven contracts, with a Departments advertised estimate amount of \$150,000 or less regardless of the bid amount.
