This is a 7-year Asset Management Services. This project includes all sections and sub sections of State Road Corridors outlined in Broward County; State Road 862 (I595) from Mile Marker 9.056 to Mile Marker 12.86, State Road 9 (I95) from Mile Marker 0.00 to 25.307, State Road 84 Westbound Mile Maker 6.65 to 12.408, State Road 84 Eastbound from 0.0 to 5.81, State Road 93 (I75) from 0.0 to 17.993. Project includes Park & Rides (Sheridan, Broward Blvd, Commercial and Cypress Creek) and Rest Area.

This addendum includes changes as detailed below:

2. Replace Section IV 4.9 ENHANCED RAMP, UNDERPASSES, AND APPROACH ROADWAYS with the following:

4.9 ENHANCED RAMP, UNDERPASSES, AND APPROACH ROADWAYS

Ramp and Underpass Maintenance is expanded as follows: Contractor is required to develop a maintenance plan that will ensure routine maintenance is conducted on the ramps, underpasses and approach roadways. The Department once every (4) four months will randomly select 10 points on ramps, underpass, and approach roadways in the project area. These points will be evaluated using MRP criteria.

The above shall be reported in the monthly O & M Report.

ENHANCED RAMP, UNDERPASSES, AND APPROACH ROADWAYS CRITERIA

Deficiency Identification	Criteria Deduction
Failure to submit contractor yearly maintenance plan to the Department.	\$1000 per occurrence
Substandard MRP for individual characteristics (Periods 1,2 & 3)	Deduct one tenth percent (0.1 %) of one-third of the annual contract amount for each point below procedural requirements for each characteristic rating

3. Replace Section IV <u>4.10 ENHANCED SOUND/BARRIER WALL/DECORATIVE RETAINING WALL/SLOPE PAVEMENT MAINTENANCE</u> with the following:

4.10 ENHANCED SOUNDWALL, CONCRETE BARRIER WALL, DECORATIVE RETAINING WALL/ SLOPE PAVEMENT MAINTENANCE

Contractor shall submit an annual report documenting or identifying areas of Sound/Barrier Wall/Decorative Retaining Wall and Slope Pavement not meeting the below requirements.

- Uniform and consistent in finish, texture, and color
- o Concrete surfaces are to be free of mildew, dirt, stains, discolorations.

Contractor shall submit an initial report, and an annual report documenting or identifying areas of Soundwall, Concrete Barrier Wall, Decorative Retaining Wall and Slope Pavement not meeting requirements. The reports shall contain the location, photos, description of deficiency, proposed corrective action.

Perform all Soundwall, Concrete Barrier Wall, Decorative Retaining Wall and Slope Pavement corrective actions identified in the annual report and agreed upon with the Department not to exceed an annual cap amount of \$200,000 cumulatively during any single contract year.
