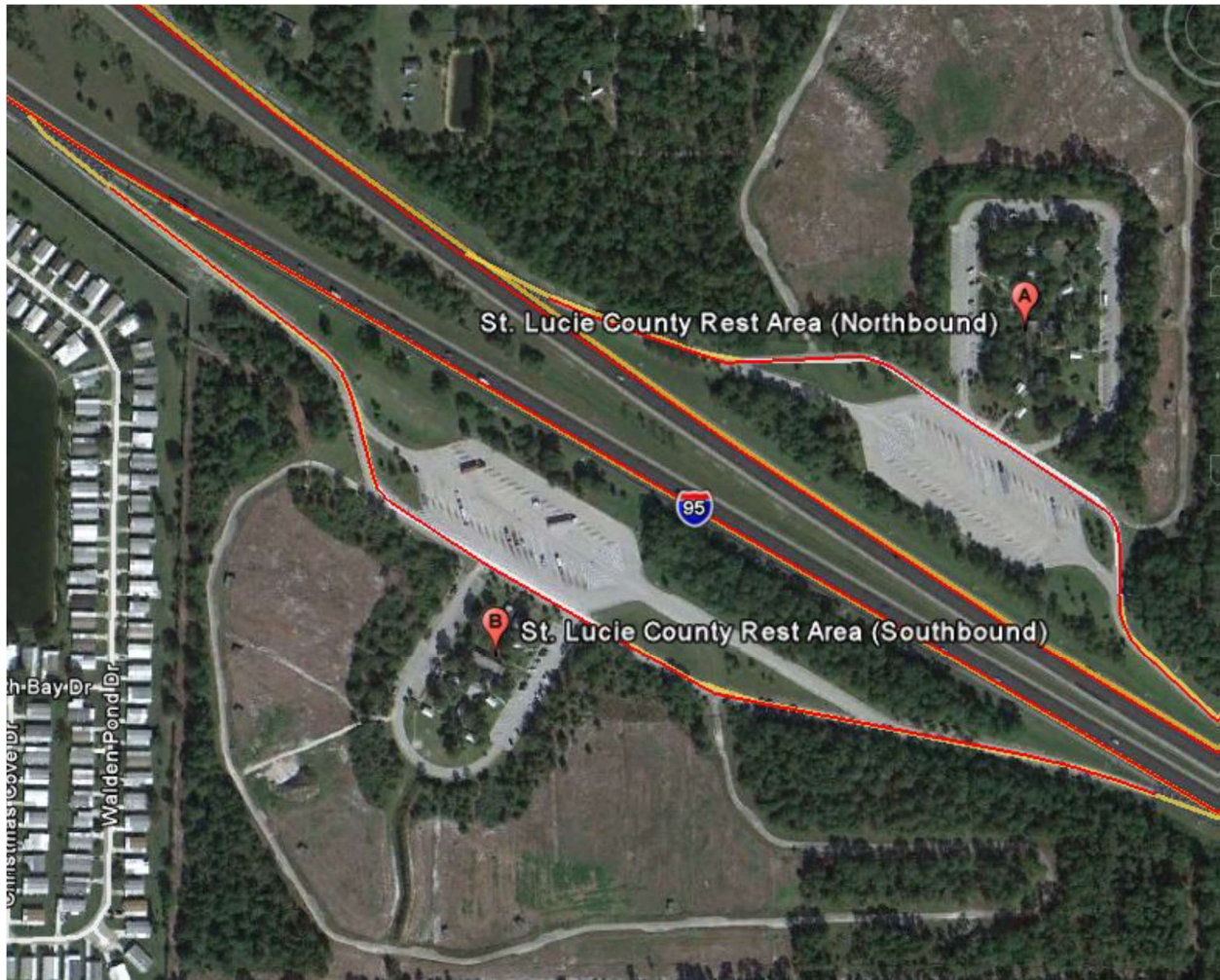

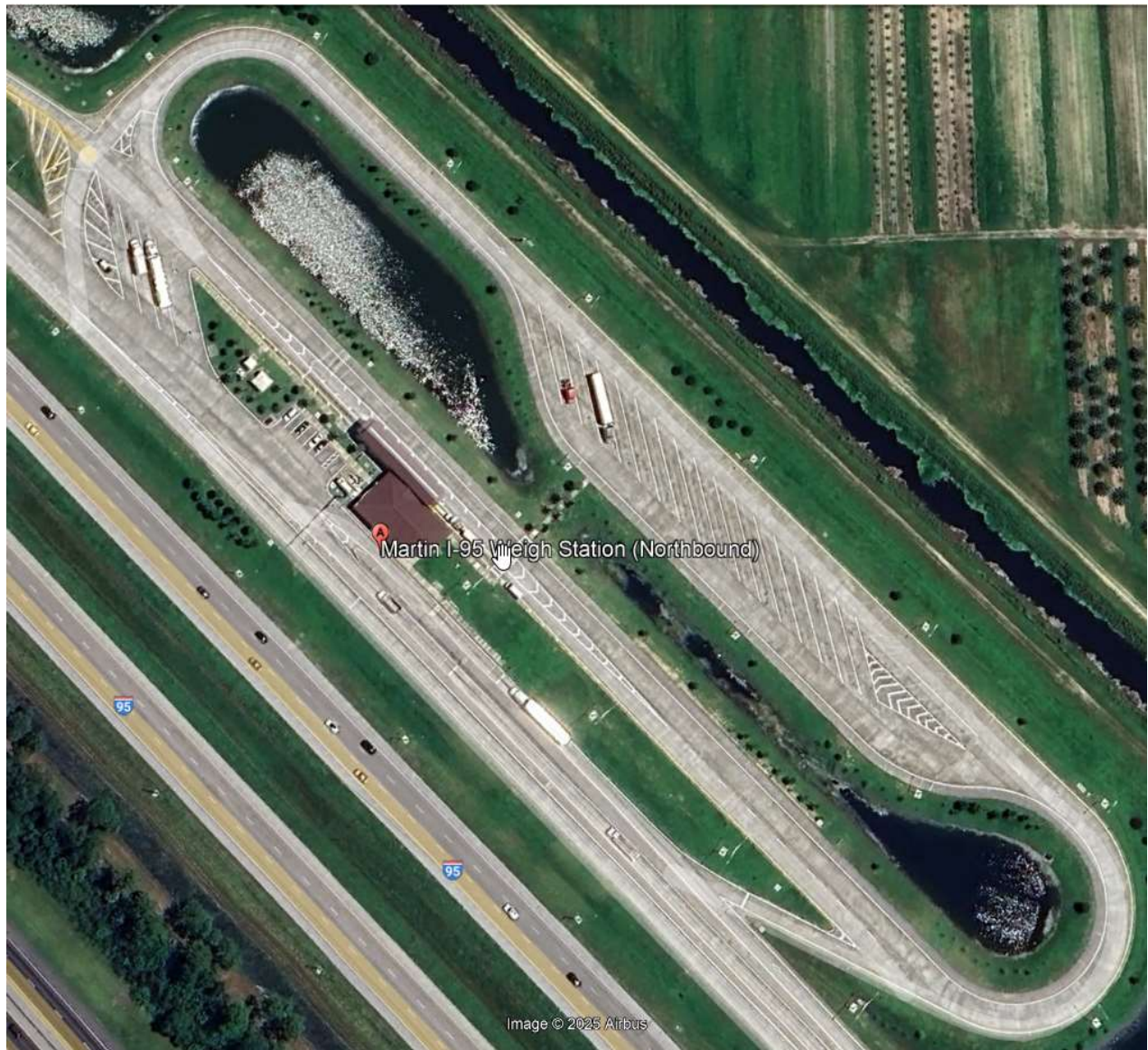
Rest Area Maps (St. Lucie)



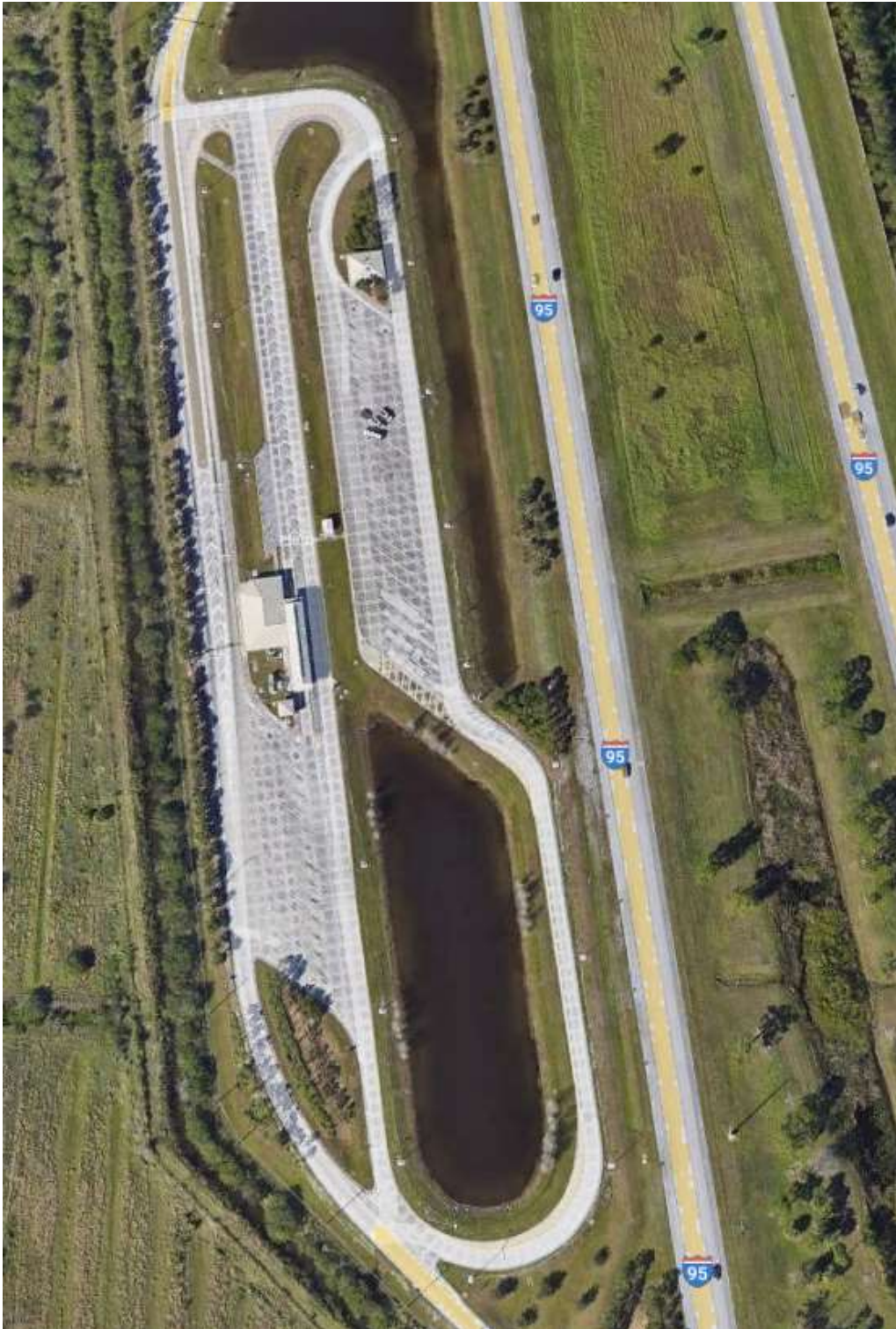
Rest Area Maps (Martin)
