The work under this Contract consists of providing all labor, materials, equipment and incidentals necessary to perform routine and priority repairs on bridges and miscellaneous structures including, but not limited to, integral pile jackets, cathodic protection, the repair or replacement of expansion joints, concrete headers, concrete parapets, fender systems, structural steel welding, beam strand and bar splices, crack injection and sealing, concrete spalls, rip rap, cleaning concrete surfaces, flowable fill, aluminum handrail, concrete slope pavement, coating of existing structural steel, bolt replacement, bolt tightening and other miscellaneous concrete and steel repairs, at various locations throughout District 4.

The work under this Contract also consists of installing aluminum angles on the existing sound barrier wall on Griffin Rd. in accordance with the Wall Repair Details and the supplementary documentation included in this package. Supplementary documentation consists of a table denoting the locations where angles are required to be installed and as-built wall plans.
