VIII. Bid Proposal Requirements.

Α. **Bid Price Proposal:**

Bid Price Proposals forms shall be submitted electronically and shall include one lump sum price for the Project within which the Proposer will complete the Project. The lump sum price shall include all costs for all design, geotechnical surveys, architectural services, engineering services, Design-Build Firms quality plan, construction of the Project, and all other work necessary to fully and timely complete that portion of the Project in accordance with the Contract Documents, as well as all job site and home office overhead, and profit, it being understood that payment of that amount for that portion of the Project will be full, complete, and final compensation for the work required to complete that portion of the Project.

Bid Price proposals forms must be submitted in the forms provided by the Department and shall be submitted electronically in a single email to the following email account: d4.designbuild@dot.state.fl.us and is due on Wednesday, May 6, 2020 by 11:00 a.m.

Emails that exceed the 10 MB email server limit may be rejected by the Department's email server. It is solely the Design Build Firm's responsibility to ensure that the bid price proposal forms are received by the Department's server by the due date and time.

The Design-Build Firm shall also submit the original Bid or Proposal Bond (375-020-34) via mail in a sealed package to the address below on May 8, 2020 by 5:00 p.m.:
