This is a Performance-Based Contract to provide Emergency Roadside Assistance Services for Interstate I-75 Northbound and Southbound beginning at mile marker 20 in Broward County and ending at mile marker 111 in Collier County. The purpose of this Contract is to provide Emergency Roadside Assistance Services during evacuation events or other events as needed.

REQUIRED SUBMITTALS WITH YOUR PRICE AND TECHNICAL PROPOSAL:

- The Contractor shall provide a letter to the Department at the time of bid, from a surety authorized to do business in the State of Florida, verifying the Contractor is bondable in the State of Florida. For the purposes of this Contract the dollar amount is established at \$250,000.00.
- Form 575-060-13 Non-collusion Declaration and Compliance with 49 CFR &29.

No quantities are guaranteed and there will be no unit cost adjustment for quantities required over or under the estimated quantities.

This contract will be awarded based on the contractors bid total for an amount of \$0 (zero) dollars and not the contractor s bid total. Additional funds will be added to the contract as needed.
