The purpose of this Contract is to provide Cut and Toss Operations pursuant to a Governor s and/or Presidential Declaration of a State Emergency. This Contract includes Broward and Palm Beach counties within District Four. At the discretion of the Department, work can be assigned in the additional counties of Indian River, Martin, and St. Lucie. The Contractor shall perform Cut and Toss Operations pursuant to the terms of this Contract and at the direction of the Department within District Four on federal-aid highway segments, local roadways, private roadways, and other locations as determined by the Department.

No quantities are guaranteed and there will be no unit cost adjustment for quantities required over or under the estimated quantities.

REQUIRED SUBMITTALS:

- The Contractor shall provide a letter to the Department at the time of bid, from a surety authorized to do business in the State of Florida verifying the Contractor is bondable in the State of Florida. For the purposes of this Contract the dollar amount is established at \$1,000,000.00.

This contract will be awarded based on the total amount of \$0 (zero) dollars and not the contractor s bid total. Additional funds will be added to the contract as needed.
