3. This Addendum changes to the RFP section 1. Proposer's Management Plan section b. Identification of Key Positions and Personnel as detailed below:

## b. Identification of Key Positions and Personnel

The Proposer should provide the names of key personnel on the Proposer's team, as well as a resume for each individual proposed and a description of the functions and responsibilities of each key person relative to the task to be performed. The Proposer shall demonstrate their understanding of the functions and responsibilities of on-site staff and identify the Contract Project Manager and other on-site staff who will remain involved throughout the Contract term. The Proposer shall also identify additional on-site staff proposed to meet the contract requirements. The approximate percent of time to be devoted exclusively for this project and to the assigned tasks should also be indicated for all key personnel. The Proposer shall include 2-page resumes for each of their key staff. The 2-page resumes are not counted towards the page limit.

4. This Addendum changes to the RFP section 21.3 Price Proposal (Part II) as detailed below:

21.3 Price Proposal (Part II)

The price proposal information is to be emailed in a separate PDF file marked "PRICE PROPOSAL NUMBER "E4X61". The Price Proposal information shall be submitted on the forms provided in the Request for Proposal.

5. This Addendum changes to Exhibit "C" Price Proposal category 11 to add more rows as needed.
