The Department will use the Proposer's substitute Price Proposal in place of the Proposer's original Price Proposal to determine the Proposer's Price Score. All original Price Proposals will remain sealed for the duration of the procurement and will not be considered by the Department. Proposers that fail to submit a substitute Price Proposal in the manner prescribed by the RFP and by **Tuesday, April 13, 2021 by 2:00 PM** will be deemed non-responsive.
