#### Intent:

Provide generator and refueling operations pursuant to the Governors and/ or Presidents declaration of a State emergency. Provide all labor, material, and equipment required to complete the work described in the Scope of Services.

No quantities are guaranteed and there will be no unit cost adjustment for quantities required over or under the estimated quantities. The Department does not guarantee any maximum or minimum quantity any range of quantities, or the exact quantity shown for each bid item. The Department established quantities and the Contractors bid price will be used to calculate a total bid amount. This total bid amount will be then used to determine the lowest bidder; however, the actual payment under the awarded Contract will be based on the actual quantities completed. When appropriate, the Engineer will issue a Task Work Order which will identify the location, description, amount of work to be accomplished, and the number of calendar days to complete the work.

There is no requirement for a bid bond. The Contractor shall provide a letter to the Department at the time of bid, from a surety company authorized to do business in the State of Florida verifying the Contractor is bondable in the State of Florida. For the purposes of this Contract the dollar amount is established at \$750,000.00.

Awarded Contractor must execute Contract documents within five (5) calendar days, excluding Saturdays, Sundays, and state holidays.

#### Note:

The Department, at its sole discretion, may award one or more Contracts. If more than one award is made, award will be based off the lowest responsive bid then the next lowest responsive bid and so forth and activated in the same order based on the Contractors availability and ability to satisfy the needs of the Department at the time contacted.
