The work under this Contract consists of miscellaneous roadside repair, including, cleaning and reshaping ditches; small machine mowing, slope mowing and litter removal; reworking unpaved shoulders and utility strips; mechanical sweeping; graffiti removal; and manual weed control in various locations on an as-needed basis.
