Intent:

The work under this Contract consists of desilting and video inspection of storm water pipes, box culverts, and other drainage structures in various locations within Department rights of way, Department owned easements or other Department owned property in Lake and Orange Counties.

The quantities shown on the Bid Price Proposal are approximate and only represent estimated planned requirements based on historical or specific project needs. The Department does not guarantee any maximum or minimum quantity, any range of quantities, or the exact quantities shown for each bid item. The Departments estimated quantities and the Contractors bid price will be used to calculate a total bid amount. This total bid amount will then be used to determine the low bidder; however, actual payment under the awarded contract will be based on actual quantities completed. Work Documents will identify the location, description, amount of work to be accomplished, and the number of calendar days to complete the work.
