These endorsements shall attest to the Florida Registered Landscape Architects support of the Contractors skills, efficiency, and competence. Each Florida Registered Landscape Architect shall sign the endorsement, provide their license number, and include the following:

- a) Project name with a brief description that evaluates the landscape work performance.
- b) Location of the project (city, state).
- c) Professional substantiation of the Contractors skills, efficiency, and competence.

A Contractor presently prequalified with the Department in "Landscaping" will suffice to meet the above requirements.
