The work under this Contract consists of turf management, litter removal, and mowing; vegetation control to include removal at all bridge approaches, abutments, on paved shoulders, and concrete pavement areas; edging; enhanced road and bridge sweeping; herbicide application; cleaning inlet throats and drainage structures; fence and gate repairs; tree trimming and removal; and delineator and object marker maintenance; mitered end section repair; maintaining/repairing sidewalks and ADA mats; cleaning roadside and outfall ditches; roadway sign maintenance over 30 SF; and coordination efforts with local municipalities and organizations.
