- a) Project name with a brief description that evaluates the landscape work performance.
- b) Location of the project (city, state).
- c) Professional substantiation of the Contractors skills, efficiency, and competence.

A Contractor presently pregualified with the Department in "Landscaping" will suffice to meet the above requirements.
