VOLUSIA COUNTY**

A. PURPOSE:

1. The Florida Department of Transportation (FDOT) requests construction services to create a new entry way into the credit union (new fire rated door assembly, new fire rated fire partition, new fire damper, ADA improvements), and provide two secure means of accessing the adjacent FDOT office space (new door assemblies with access control hardware – coordinated with fire rating of assembly) and indicated ADA improvements.
2. The Contractor shall provide services, material, and labor, in accordance with the attached Contract Plans.
3. In addition to the Contractor's Proposal, the items within the Contract Plan shall be incorporated and become part of the Contract Agreement.

B. WORK SITE CONDITIONS:

1. Prior to the start of work, the Contractor and Department Representatives shall identify on site locations for the staging of material, trash disposal bins, portable sanitary facilities, and break area for workers. The Contractor shall be responsible to maintain these areas in a neat, orderly, and safe fashion during the entire project. (see section (B-17) Non-Technical Specifications).
2. The Contractor shall follow all applicable safety practices on this job. Occupational Safety and Health Administration (OSHA) regulations shall apply.
3. The Contractor shall maintain a full-time Supervisor/Foreman on the job site during all work hours. The Supervisor shall be qualified and experienced with the materials and application process being installed.

C. CONTRACT:

1. The Contractor shall have (120) Calendar Days from issuance of Notice to Proceed to complete the project. (reference (A-22) Non-Technical Specifications).
2. For bids exceeding \$100,000, a bid proposal guarantee of 5% of the bid amount must accompany the bid proposal, or the bid shall be deemed non-responsive and rejected. (reference (A-2) Non-Technical Specifications)

D. WORK HOURS:

1. Primary work on this project shall be performed during the weekday hours which Monday - Friday 8:00 am to 5:00 pm, except for the installation of the sanitary line. The contractor shall request and receive the Departments approval for any project activity outside of the weekday hours listed above.

E. ADDITIONAL DOCUMENTS:

The Contractor shall submit the following documents with the executed Contract Agreement Package.

1. A copy of current State of Florida Business License (must be submitted with the bid proposal).
2. Documentation from the Product Manufacturer indicating the Contractor is an Approved Installer of the product and system being proposed.
3. Certificate of Insurance. (reference (B-3) Non-Technical Specifications).

F. WARRANTY:

1. As per proposal, upon Contract completion the Contractor shall provide a written two (2) year labor/installation warranty on their work and a five (5) year Manufacturer Material Warranty.

G. METHOD OF COMPENSATION:

1. Compensation shall be paid in accordance with Section B-21 (Progress Payments) and Section B-22 (Final Payment) of the Non-Technical Specifications.
