- 1) Special Events include, but are not limited to, Magic basketball games, and events at the Camping World Stadium, Amway Center, Orlando City Stadium, Dr. Phillips Center for the Performing Arts ; University of Central Florida Home Games, Red Hot & Boom Fireworks Display, Daytona Bike Week, Biketoberfest; Lake County Youth Fair, Clermont Pig on the Pond, National Night Out, Leesburg Bike Festival, George Fest Parade, and Mount Dora Art Festival.
- 2) Non-located / unmarked FDOT ITS facilities, including fiber optic communication and traffic control signal loops/devices, may exist within the project limits; make temporary repairs to any damage to a facility within four (4) hours of the occurrence. If assistance is required regarding ITS facilities, contact the FDOT Traffic Operations ITS Manager at (386) 943-5000.
- 3) Traffic Monitoring Sites may be located within work locations; do not disturb the area near these sites. In case of any damage, immediately notify the District Traffic Operations Office, District Data Collection Manager at (386) 943-5380.
- 4) Aesthetics Activities (Small Machine Mowing, Litter Removal, etc.): The intent of this Contract is not to establish regular cycles in any particular location. Work Documents that include these activities will be on an as-needed basis.
- 5) Lane Closure Restrictions: Specific lane closure restrictions apply to most of the roadways within the Project limits. If applicable, such restrictions will be included in the Work Document.
