• The following response to the Q&A is modified in red text:

Question: 18465: As per Conceptual Plans - Typical Mast-Arm Video Detector Posted: 4/18/2017 3:35:16 PM Camera Mounting Note No. 17. DBF is required to furnish and install one video processor card per cameras. However, MD660X has 8 racks positions for secondary vehicle detection. Conceptual plans shows more than 8 CCTV per intersections at some locations. This layout is in conflict with the MD660X input file assembly capabilities. Can the Department confirm that only eight (8) CCTV cameras will be required at a maximum per intersection?

FDOT Answer: Based on the concept plans for NW 27 Ave and 119 Street 9, video detection cameras to be installed as per MDC requirements and Project's advance detection needs. FDOT and MDC are evaluating allowing/using 2 cameras on one video processor card. Please plan on installing 9 cameras at

this location. During the Project's design phase, FDOT and MDC may require change from 9 cameras to 8 cameras. In addition, the Design-Build Firm is responsible for appropriate product selection and cabinet configuration (including shelf-mounted rack extensions) as needed to support the video detection system.

## All other documents of the subject project remain unchanged.
