**Description:**

Electronic bids are requested for a Work Order driven contract that consists of providing labor, equipment and materials to repair existing asphalt pavement on various sections of state roads in Miami-Dade County. Some potential locations for milling and resurfacing are listed in Attachment "A" on the specification package. The Department's estimated quantities and the Contractors' bid price will be used to calculate a total bid amount. This total bid amount will then be used to determine the low bidder; however, actual payment under the awarded contract will be based on actual quantities completed. For this Contract in which specific sites are not identified at the time of letting, the Engineer will issue a Work Document. Work Documents will identify the location, description, amount of work to be accomplished, and the number of calendar days to complete the work.

Award will be made at the Budgetary Ceiling amount of \$135,000.00.
