Question:

25399: General Note 5 on Sheet 26 states NO WORK to be done outside the shoulder from Sta. 115+00 to Sta. 722+00 from November 1 to April 30. This is 182 days. It seems unrealistic to block out 182 days out of 400 days where no work can be done on the grading, utilities, drainage, utility work and sod during this time. Assuming the normal time from letting to NTP of approximately 90 days plus the allowable flex time of 15 days, it is reasonable to assume the work would not start until around the middle of August. This would allow only 2 ½ months of work on the stated items until you would have to shut down for 6 months. Resuming work in June, 2020 would leave less than 5 months to

complete all the remaining items.

If all work within the shoulder to shoulder envelope is complete and the only remaining work items are beyond the shoulder line, will time be added to the 400 day completion window by the number of days the Contractor was unable to work due to General Note 5?
