29496: Roadway plans for the 3-FIN #, Sheet No. 4, notes for details B & C state the cost for milling and SP asphalt under the traffic separator are to be included in the costs of the traffic separator. Roadway plans for the 4-FIN #, Sheet No. 15, is another detail for the traffic separator that depicts type B stab. OBG 9, and 2 lifts of asphalt under the traffic separator but no reference about these quantities having to be included in the cost of the traffic separator. Please confirm quantities for these activities will be paid separately through contract pay items. Note 2, same detail "contractor has the option of either the option I or option II" seems to be contradicting the detail. Please confirm that the note supersedes the detail and Option I is allowed where no asphalt under the traffic separator is required. Lastly, the traffic separator (type IV) (Option II) legend has a (3) subscript and OBG 9 legend has a (4) subscript. There's no notes 3 or 4 on the sheet. Please clarify.

29508: The answer for the question ID: 29496 doesn't completely address all the concerns about the traffic separator at the -4- FIN #. The detail for type IV option II shows 2.5" of asphalt and note 2 gives the contractor the possibility to build option I, WHICH DOESN'T REQUIRE ASPHALT AT ALL. PLEASE CLEARLY CONFIRM THAT OPTION I CAN BE USED, PLEASE DON'T REFER TO ANY SPEC. Also, the section 520-4 states "I and compact the foundation material upon which these items are to be placed as specified in 120-9". The spec 520-12.1 cited in your answer only states "asphalt pavement and base" however, no specific requirement exists for OBG 9 to be built under the traffic separator. We understand the goal should be for all the prospective bidders to be able to bid under the same scope, with the same criteria. PLEASE BE CLEAR ENOUGH ABOUT HOW DO YOU WANT ALL THE CONTRACTORS TO BUILD THE TRAFFIC SEPARATOR.
