28848: Spec Section 570-3.1 states "The Dept. will only pay for replanting as necessary due to factors determined by the Engineer to be

beyond the control of the Contractor.

Part 570-4 states "Established turf is defined as follows: I 7. No competing vegetation, exotic or invasive plants pests or noxious weeds."

It's our experience that the allowable Performance (Perf.) Turf option of seeding does not withstand rain or erosion events that are very common. Specifically, with slopes as steep as 2:1 & existing soil conditions on this project. The existing weeds & other vegetation in the existing soil does not allow for established seeded turf free of competing vegetation, exotic or invasive pest, & plants or noxious weeds.

Has the EOR considered the existing seed sources, existing soil materials, proposed slopes & allowable embankment materials when specifying the Perf. Turf pay item (seeding)?

Will the Department consider changing the Pay Item for Perf. Turf pay item to Perf. Turf - Sod?

Typical Section No. 1 (located on Sheet No. 16) and Typical Section No.2 (located on Sheet No. 17) show the 12" stabilization (LBR 40) matching the OBG 1 area, which is consistent with the plan quantities for the pay item 0160-4 (176,061.00 SY) and the pay item 0285-701 (176,067.00 SY), however, the shoulder pavement widening detail depicted on Sheet No. 19 shows an additional width of 5' where 12" stabilization is to be performed and sod is to be placed. These extra 5' of 12" stabilization are not depicted in either typical section. Please clarify which sheet is to be followed? In the event The Department decides to proceed with the detail on Sheet No. 19 please make sure you include an addendum with a much higher plan quantity for the 12" stabilization pay item 0160-4.
