Description:

This performance-based contract requires the inspection, management and performance of the maintenance of all components of the transportation facility as identified herein.

The First Coast Expressway (FCE) / State Road 23 (SR 23), is a new multi-lane limited access toll facility that will eventually connect Interstate 95 (I-95) in northern St. Johns County to Interstate 10 (I-10) in western Duval County. FCE Section 1 is a 15-mile, four lane, divided limited access toll facility and will feature seven (7) interchanges and five (5) mainline gantries. FCE Section 1 will be delivered under two projects. The first project is from State Road 21 (SR 21) (Blanding Boulevard) to north of Argyle Forest Boulevard (approximately 7 miles). Work began in May 2014 and is targeted for completion in fall 2018. The second project is from north of Argyle Forest Boulevard to I-10 (approximately 8 miles). Work began in May 2013 and is targeted for completion in fall 2018.

*The Toll Equipment Buildings supporting the Express Lanes along Interstate 295 (I-295) in Duval County are included as part of the limits of this Contract.

The Express Lanes project along I-295 from I-95 to the Buckman Bridge includes construction of two additional 12-foot travel lanes (the tolled express lane) in each direction, toll equipment buildings and installing electronic tolling systems at various locations to collect tolls. This project has been completed in mid-2018.

The Express Lanes project along I-295 from J. Turner Butler Boulevard to State Road 9B includes construction of two additional 12-foot travel lanes (the tolled express lane) in each direction, toll equipment buildings and installing electronic tolling systems at various locations to collect tolls. This project is expected to be completed in mid to late 2019.
